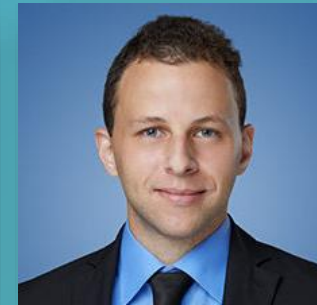

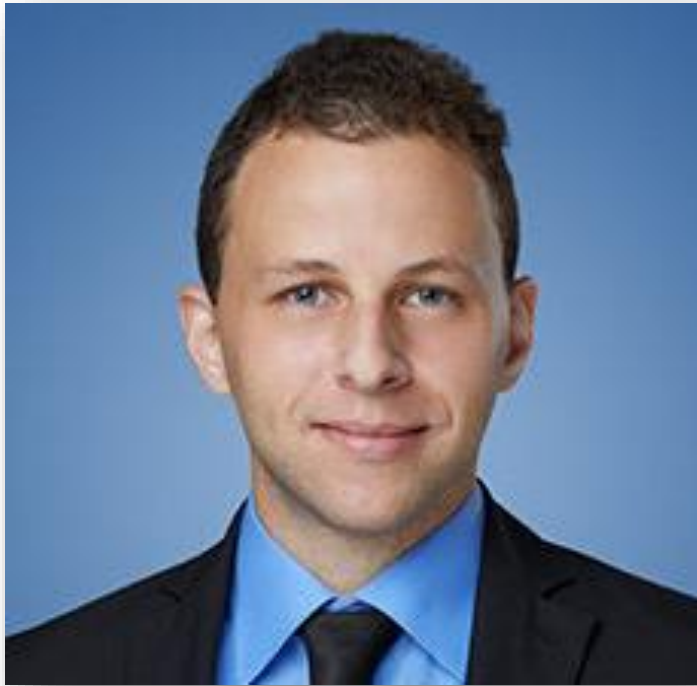

What are the “Sadowski Trust Funds”

- Established in 1992
- Consists of two trust funds:
 - **State Housing Trust Fund** – primarily funds the State Apartment Incentive Loan (SAIL) program
 - **Local Government Housing Trust Fund** – funds the State Housing Initiatives Partnership (SHIP) program
- Funded by a portion of documentary stamp taxes collected on real estate transactions
- Collections in the trust funds are directly tied to the real estate market – the hotter the real estate market, the more money in the affordable housing trust funds

New Era for Sadowski Trust Funds

- “Stop the sweeps” era = nearly a 20-year movement to ensure the Legislature did not “sweep” funds from our state’s affordable housing trust funds to other purposes
- As of 2021, no more sweeps by law
- SB 2512 (2021) put into law that funds in the State and Local Government Housing Trust Funds “may not be transferred to the General Revenue Fund in the General Appropriations Act” F.S. 201.15(5)
- This new law “prevents” future sweeps

2023 Housing Funding Priorities

1. **Keep the promise** to use all of Florida's Sadowski Housing Trust Fund monies for Florida's SHIP and SAIL programs.
2. **Additional funding** for housing programs or projects outside SHIP or SAIL to help alleviate Florida's deficit of housing with the funding coming from general revenue or sources other than the Sadowski Trust Funds

Legislative Process

- Session begins **March 7, 2023.**
- Remaining committee weeks are:
 - Feb. 6-10
 - Feb. 13-17
 - Feb. 20-24
- Remaining District Office weeks are:
 - Jan. 31-Feb. 3
 - Feb. 27-Mar. 3
- Consideration of the appropriation of the state and local housing trust fund programs is underway.

How does the Legislature make appropriations?

- By passing a Budget Bill also known as the Appropriations Act
- There is no “housing bill” for appropriations
- There is an Appropriations Committee in the House and an Appropriations Committee in the Senate
- When the Senate and House Appropriations Committees agree on the amounts of money to allocate for the state and local housing programs (SAIL and SHIP, primarily), it becomes law (after signed by the Governor)

Appropriation of Trust Fund Monies

Revenue estimate from January 2023 REC Conference

FY 23-24: SB 102:

- \$100 million of non-recurring General Revenue for SAIL deals in pipeline (CHIRP-like), reverting to SAIL if not used for pipeline
- \$100 million of non-recurring General Revenue for Hometown Heroes
- 10-year redirection of doc stamps now going to GR redirected to SAIL, \$150 million/year

FY 22-23: Proviso/Back of the Bill (Senate):

- \$25 million of non-recurring General Revenue for SAIL, bringing total to \$53,250,000

FY 22-23: Special Session Appropriations-- \$150 million of General Revenue

- \$90 million for Rental Recovery Loan Program (SAIL-like) for areas impacted by Hurricane Ian and Hurricane Nicole. \$60 million for Hurricane Housing Recovery Program (SHIP-like) for areas impacted by Hurricane Ian and Hurricane Nicole

Message

- **Sadowski is the floor, not the ceiling.** Appropriate all the Sadowski state and local housing trust funds solely for Florida's housing programs.
- **Additional funding is welcome.** Local member projects and other housing initiatives can be funded but use General Revenue or other funds – leave Sadowski alone.
- We have a housing crisis.
- We have the best housing programs in the nation.
- Housing fuels the economy.

How do we know how much money to ask for?

- We ask for the appropriation of **all** the state and local housing trust fund money; the money collected from the portion of the doc stamp that is dedicated for affordable housing.
- The trust fund money is automatically deposited into the state and local housing trust funds by operation of law (that's what the Sadowski Act- which passed in 1992 accomplished- we have a dedicated revenue source for housing).

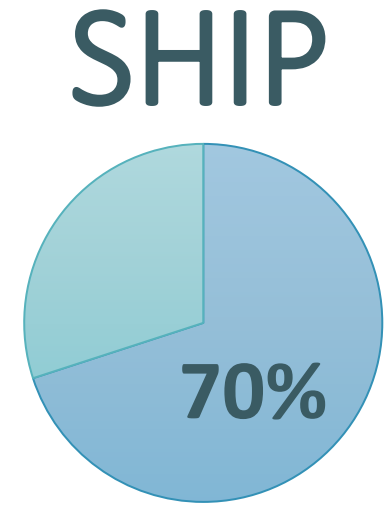

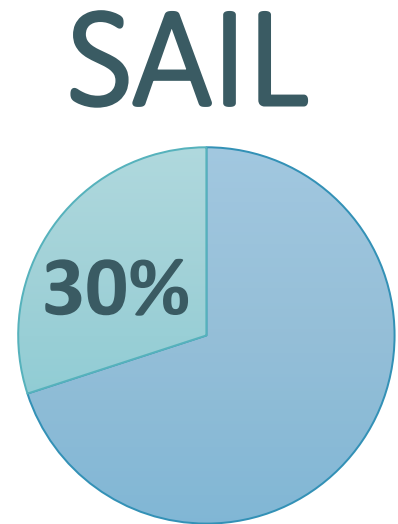


What is the Split Between Local SHIP and State Programs

70% goes to the Local Government Housing Trust Fund for the State Housing Initiatives Partnership (SHIP) Program



30% goes to the State Housing Trust Fund for the Florida Housing Finance Corporation programs such as the State Apartment Incentive Loan (SAIL) Program

What to expect in the 2023 Legislative Session

- Senate President Kathleen Passidomo has made affordable housing a priority
- We expect record levels of affordable housing funding and substantive policy changes & additions to state law
- Senate Bill 102 was filed on Jan. 26 and will be the vehicle for a number of housing policies

Senate Bill 102 – Housing (original filed version)

HIGHLIGHTS

- Funding:
 - Provides up to an additional \$150 million/year for 10 years for SAIL
 - 70% of additional funds must be used for listed projects in the bill including adaptive reuse, urban infill, mixed-use development, and rehab/construction
 - Remainder of funds can be used for projects that use or lease public lands, address needs of youth aging out of foster care, meet the needs of elderly persons, or provide housing to meet the needs in areas of rural opportunity
 - Creates new “Live Local Program”
 - New tax donation program to allow taxpayers to direct funds to FHFC for use as SAIL funds in exchange for corporate tax and insurance liability tax credits
 - Annual cap of \$100 million

Senate Bill 102 – Housing (original filed version)

- Funding:
 - \$100 million for the Hometown Heroes Program from GR
 - \$252 million for SHIP
 - \$259 million in total for SAIL
 - \$100 million in a CHIRP-like program from GR

Senate Bill 102 – Housing (original filed version)

- Zoning, land use, and local government generally:
 - Amends HB 1339 land use tool to remove “residential” and remove the prohibition on SAIL-funded projects
 - Preempts local governments on zoning, density, and height for certain multi-family developments in commercial areas with at least 40% affordable units
 - Amends surplus land statute
 - Prohibits rent control
 - Addresses using state-owned lands for affordable housing

Senate Bill 102 – Housing (original filed version)

- Tax exemptions/incentives:
 - New affordable housing property tax exemption for developments over 70 units that provide affordable housing that are not in contract with FHFC
 - Allows local governments to provide property tax exemption for developments serving households 50% or below AMI
 - New sales tax refund for affordable housing construction

Senate Bill 102 – Housing (original filed version)

- Other topics:
 - Substantial changes to the state housing strategy
 - Address FHFC board makeup
 - Authorizes FHFC to contract with Catalyst provider to provide specific training on using publicly-owned land for affordable housing

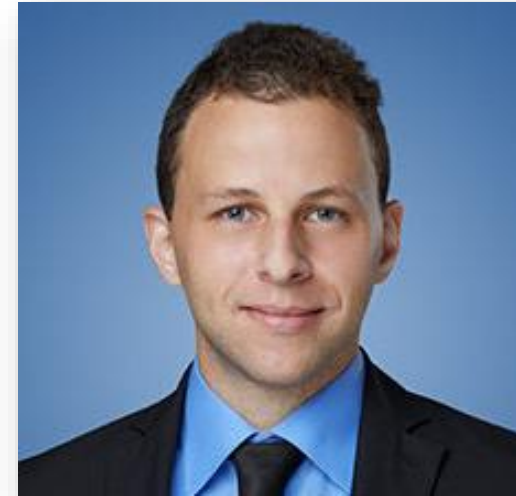
