Where We Are Now

- Early advocacy and negotiations had an impact in improving SB 2512
- This year: \$146.7 million for SHIP and \$62.5 million for FHFC (SAIL & other Programs)
- SEED is no longer funded from housing
- Housing Appropriations are recurring
- Housing funds may not be swept
- Call to Action for the \$225 million in nonrecurring funds could have had a better response







Next Steps

- Education, Education
- Between now and the end of summer
- Every legislator even those who are champions
- Why SHIP and SAIL are so critical
- Difference between SHIP and SAIL and the federal funds
- We need to better education and advocacy for additional nonrecurring funds

Using ARPA Funds for Housing

- The American Rescue Plan Act contained a variety of funding sources for state and local governments. Two groups of funding in particular have an effect on housing.
 - 1. State and local fiscal recovery funds
 - 2. Specific Housing provisions (emergency rental assistance, homeowner assistance, homelessness assistance, etc.)
- Cities and counties in Florida can expect to receive an allocation under Subtitle M of the American Rescue Plan Act which is titled "Coronavirus State and Local Fiscal Recovery Funds."
 - Subtitle M is how the state of Florida received the over \$10 billion for COVID relief.
 - Projected distribution examples:
 - Pinellas County: \$189 million
 - Leon County: \$59 million
 - Ocala: \$11 million
 - Broward County: \$379 million
 - Miami-Dade: \$527 million



Coronavirus State and Local Fiscal Recovery Funds

- Eligible Uses of funds
 - 1. Respond to public health or negative economic impacts of COVID-19, including "assistance to households, small businesses, and nonprofits"
 - 2. Provide premium pay to essential workers
 - 3. Provide government services to the extent of the reduction in revenue due to COVID-19
 - 4. Make necessary investments in water, sewer, or broadband infrastructure.
- Grantees have until 12/31/24 to spend the funds
- US Treasury Department to provide guidance



Using Local Recovery Funds for Housing

- Local governments can expressly use Local Fiscal Recovery funds to respond to public health or negative economic impacts of COVID-19, including "assistance to households, small businesses, and nonprofits"
- Grantees can use these funds for housing unless upcoming Treasury guidance restricts their use
- Ideas for using these funds:
 - Eviction/foreclosure prevention funds to individuals
 - Small-scale landlord rental relief
 - Permanent affordable housing to house persons displaced by COVID-19's economic effects
 - Grants or loans to nonprofit organizations to provide supportive services and/or housing



Homeowner Assistance Fund

- American Rescue Plan Act allocated \$10 billion nationwide for a Homeowner Assistance Fund (HAF)
- The Florida Department of Economic Opportunity (DEO) will administer the state's funding
- Florida will receive \$676.6 million
- Eligible uses:
 - Mortgage payment assistance
 - Financial assistance to allow a homeowner to reinstate a mortgage or to pay other housing-related costs related to a period of forbearance
 - Mortgage principal reduction
 - Facilitating mortgage interest rate reductions
 - Payment assistance for utilities, internet service, insurance, HOA fees or liens, condo fees, DPA loans
 - Payment assistance for delinquent property taxes
 - Measures to prevent homeowner displacement, such as home repairs or assistance to enable households to receive clear title to their properties
 - Counseling efforts



Emergency Preparedness & Response Fund

- House Bill 1595 (Williamson)/Senate Bill 1892 (Diaz)
- Creates the Emergency Preparedness and Response Fund within the Executive Office of the Governor
- Fund intended as "primary funding source for the Governor for purposes of preparing or responding to an emergency"
- State can use this fund for immediate response and replenish the fund with reimbursements from FEMA, CDBG-DR, or other federal and state dollars
- House and Senate have agreed to appropriate \$1 billion for this Fund

As the dedicated disaster trust fund, this fund should be the first source of dollars to respond to disasters.

Florida Housing Finance Corporation (Rep. Roth/Sen. Rodriguez)

- Elevates the status of the Sadowski Housing Trust Funds; bars Legislature from sweeping unappropriated cash balances from the State and Local Government Housing Trust Funds
- Language in HB 5401/SB 2512
- Extends Hurricane Loss Mitigation Program (HLMP) to June 30, 2031
- Passed by full Senate; in House Appropriations
- Preempts local governments from regulating building design elements for single & two-family homes with certain exceptions.
- Passed by full House; in Senate Rules
- Forms the Resident Florida Grant Program; requires DEP to complete a comprehensive statewide flood vulnerability and sea level rise assessment; & more
- Passed by both House and Senate
- Gives FHFC board the authority to make final determination on issuance of revenue bonds
- First hearing in House Ways & Means on 3/31

Housing Bills Heard in Committee

HB 1193/SB 1746

Court Records of Eviction Proceedings (Rep. Aloupis/Sen. Jones)

- Authorizes tenants, in certain circumstances, to have eviction records sealed.
- Passed full House; in Senate Rules Committee

HB 883/SB 60

County and Municipal Code Enforcement (Rep. Overdorf/Sen. Bradley)

- Prohibits code enforcement officers from investigating or initiating code enforcement proceedings based on an anonymous complaint.
- Passed full Senate; 2nd reading in House

HB 219/SB 522

Vacation Rentals
(Rep. Fischer/Sen. Diaz)

- House/Senate versions differ. Preempts regulation of advertising platforms to the state and makes changes to local government authority to regulate vacation rentals.
- Stalled

HB 1059/SB 1788 Construction Permits (Rep. Robinson/Sen. Boyd)

- Requires LGs to post building permit applications online, allow applicants to submit electronically, and post permit review processes.
- Passed full House; on Senate floor





Housing Bills Not Heard in Committee

HB 567/SB 1068

Local Housing Assistance Plans (Rep. Bartleman/Sen. Taddeo)

Makes changes to SHIP set-asides

HB 563/SB 674

Tax Exemption for Affordable Housing (Rep. Rodriguez/Sen. Rodriguez)

• Allows local governments to grant ad valorem tax exemptions for affordable housing developments

HB 499/SB 576 Prohibited Landlord Practices (Rep. Benjamin/Sen. Jones)

 Prohibits landlords from refusing to rent to a tenant solely based upon the tenant being previously evicted during COVID-19

HB 481/SB 412 Residential Evictions (Rep. Driskell/Sen. Rouson)

• Repeals Florida's "pay-to-play" Landlord/Tenant Statute
