- Expands partnerships and collaborations within the Regional Health Care system.
- Negotiates and monitors contracts with partner agencies.
- Analyzes and prepares contracts and related budgets.
- Coordinates, manages, collects, and/or prepares program data, reports, and attainment of goals and objectives of the Opioid Settlement.
- Receives inquiries and concerns, ascertains the nature of the request, and personally resolves, directs to the appropriate health care entity, or acts as a liaison to the appropriate individual.
- · Attends meetings for the dissemination of information as required.
- Performs duties as assigned/necessary related or logical in assignment to the position.
