The following TA can be incorporated into any of the above packages a la carte:

- -Non Homeownership Ground Lease Development and Fee Calculation
- -Incorporating and aligning affordability provisions into Condo and/or HOA documents
- -Developing an advertisement to procure, evaluate and identify an organization to serve as  $\operatorname{CLT}$
- -Drafting a business plan and budget that implements strategies for long-term sustainability
- -Personnel activities such as establishing job descriptions that support a successful operation
- -Marketing plan preparation
- -Lead the administrative and operational activities of the CLT including compilation of a development team (contract, architect, entitlements, etc.) that will endeavor to facilitate the production and sale of homeownership unit(s).
- -Procurement of an organization to serve as a CLT or shared equity partner with a local government. Subsequently, work to fully establish a certified operation with the selected entity and LG can continue through an applicable package shown above.
